
**NOW, THEREFOR BE IT RESOLVED** that the Board of Commissioners of Mason County Fire District #13, as follows:


**SECTION 1.** That the district shall provide emergency medical care or emergency medical services, including related personnel costs, training for such personnel and related equipment, supplies, vehicles, and structures needed for the provision of emergency medical care or emergency medical services.


**SECTION 2.** In order to produce the revenue adequate to pay the costs of providing life protection services as described in Section 1 of this resolution and to maintain reserve funds sufficient to assure the continuation of such services, the district shall levy for six consecutive years beginning in 2016, and collected in 2016, a general tax on taxable property within the district, maintenance and operation costs in the amount of \$.50 per \$1,000.00 of assessed valuation.

**SECTION 3.** There shall be submitted to qualified electors of the district for their ratification or rejections at an election on February 10, 2015 the question of whether or not such levy for maintenance and operations shall be made.
